He also is counsel to several national major food production/distribution and manufacturing companies, negotiating collective bargaining agreements and handling related matters with several unions, including the Teamsters, Steelworkers, the UFCW, the IAM and others.

He has served as lead defense counsel in numerous employment actions for companies located throughout the East Coast, and has obtained several defense verdicts for employers in discrimination cases that have gone to trial. He served as lead defense counsel in obtaining summary judgment in federal court in a same-sex sexual harassment case for a major soft drink company. That case was a case of first impression and was affirmed on appeal by the Third Circuit.

A frequent lecturer and writer, Mike has spoken before a variety of organizations and trade groups on labor and employment topics. He has been a contributing author to the annual update of the *Pennsylvania Employment Law Guide* and for *The Developing Labor Law*. Mike also writes quarterly articles on current trends in employment law for the Interior Finish Contractors Association's newsletter and has been a panelist at the Federal Mediation and Conciliation Service's Annual Arbitration Symposium. He also has served as an Adjunct Professor of Trial Advocacy at Rutgers-Camden School of Law.
